AND OBSERVERS ARE REQUIRED TO ASSUME ALL RISKS BY SIGNING THIS RELEASE.

I hereby acknowledge that I have voluntarily applied to participate in / or observe the sport of COWBOY ACTION SHOOTING and any related activities.

As lawful consideration of being permitted to enter upon the premises on which these events are conducted and of being permitted to participate in or observe activities or otherwise use the facilities, the undersigned for myself (and/or my child or ward as the case may be), my heirs, distributees, legal representatives, next of kin and assigns agree to the provisions set forth below.

1. I am aware that the participation in and/or observation of the sport of COWBOY ACTION SHOOTING with loaded firearms can be a hazardous activity. I do voluntarily participate in or observe these activities with the knowledge and appreciation of the danger involved. I hereby agree to accept any and all risk of property damage, personal injury and/or death.
2. I hereby release, waive, discharge and covenant not to sue, make any claim against the property of or otherwise prosecute any action against The Scioto Territory Desperados Inc., the Single Action Shooting Society and Cardinal Shooting Center, property owner, 616 State Route 61, Marengo, OH, 43334, and/or their officers, directors, shareholders, agents, members or employees, (Releasees) herein after and forever, for any liability on account of damage to property or injury to any person or death to the undersigned. I expressly agree that the foregoing Release, Waiver and Indemnity Agreement is intended to be as broad and inclusive as permitted under the laws in the State of Ohio.
3. I give consent for whatever medical care might be provided or available on the premises in event of an accident.
4. I agree to indemnify, reimburse and fully compensate any and all Releasees for any costs, expenses and damages including reasonable attorney fees resulting from any claim brought against Releasees as a result of my actions and/or inactions.
5. I further agree that my image may be made in either still or video/motion photography and/or digital imagery for any use.
6. I have read carefully and fully understand the above and voluntarily sign this release, I am over 18 years of age and if signing the agreement on behalf of a minor state that I have legal authority to act on behalf of such person and bind him/her to the terms of the agreement.
